League President Compliance Statement

I, the League President of (League name) _____, hereby state as follows:

1. I understand that concussions in youth sports has been addressed by the Ohio General Assembly through the approval of HB 143, and that Ohio Revised Code Sections 3707.51, its subparts, and Section 3707.52 have been created and/or amended as a result; I have reviewed the requirements of HB 143 and the Ohio Revised Code concerning concussions in youth sports, known as Ohio's Return to Play Law (ORPL); I understand that I am responsible for providing on an annual basis to the parent, guardian, or person responsible for each player on the team the concussion and head injury information sheet required by Section 3707.52 of the Ohio Revised Code; I state that I have informed every one of our coaches of the requirements of ORPL and that every coach for our team either holds a Pupil Activity Permit issued by the Ohio Department of Education pursuant to Ohio Revised Code Section 3319.303, or has presented evidence to us that they have successfully completed, within the previous three (3) years, a training program in recognizing the symptoms of concussions and head injuries to which the Ohio Department of health has provided a link on its internet website under Section 3707.52 of the Revised Code. I understand that ORPL requires players to be removed from practice and/or games if they exhibit any signs of a concussion or head injury pursuant to Section 3707.511 (D) of the Ohio revised Code and that once the same has occurred that the player may not return until the procedures outlined in Section 3707.511 (E) (1) of the Ohio Revised Code and its subparts have been fully complied with. I further state that all coaches are familiar with and understand these requirements fully; and

2. I further understand that my League will conduct all required background checks on all officials, Managers, coaches, umpires, volunteers and staff (and any other individuals that may come into contact with minors of the organization). Such background checks will at a minimum be a search of the National Sex Offender Database.

3. By signing below, I also understand that it is my responsibility to comply with the criminal background checks as described above. Tri-T Baseball/Softball shall have no responsibility to conduct such checks. Tri-T Baseball/Softball is hereby released of any liability with respect to such background checks and I will defend, indemnify and hold Tri-T Baseball/Softball free and harmless from and against any claims, damages, or losses related thereto.

By signing below, I understand and also state affirmatively that it is my responsibility to ensure that all coaches involved with our league are trained and comply in all ways with the Ohio Return to Play Law, and that it is not the responsibility of the Tri-T Baseball/Softball League, its Board of Directors, assigns, employees, agents, or officers to ensure that member leagues or teams, and their coaches meet the requirements of ORPL. Further, I understand and agree that the Tri-T Baseball/Softball League is hereby released from any and all liability related to our team, its players, and its coaches, in any way related to or as a matter of the ORPL and I hereby agree to indemnify the Tri-T Baseball/Softball League in all respects for any claims losses or damages of any kind resulting from ORPL.
